

Headquarters upon where you're duly assessed and a permanent position as Product Analyst is offered.

You should bear in mind that the Entry Level Tester NPT25/26001 position is temporary, and your performance in this survey will be a key factor in qualifying for a permanent role.

Additionally, purchase a unit of \$500 Nike gift voucher for subsequent gift voucher evaluation.

Once your purchases are complete, organize all items and supporting materials for submission and reporting.

Reminder: At any store chosen for the Nike gift card purchase, under no circumstances should you acknowledge you are evaluating their services, as that will compromise the integrity and objectivity of the survey process.

Before proceeding to the report submission portal, please ensure you have the following information and materials ready:

- All four (4) Nike gear items listed in Section 1
- One (1) unit of \$500 Nike gift card purchased at a Nike Store
- One (1) unit of \$500 Nike gift card purchased at CVS, Walmart, Walgreens, or any local retail store
- Receipts for purchases made at both Nike and CVS (or applicable local store)
- Store name, address, date, and time of visit
- Name of the cashier/attendant (If visible on tag)
- What was your overall experience with the staff in the store?
- How long does it take you to get checked out

Image Submission Requirements:

- Nike Gear Items:
 Capture clear images of the barcode area of each item. If the price is visible, ensure it is clearly shown
- Gift Cards:
 Provide clear images of both the front and rear sides of each gift card.

Before capturing the back of the card, gently peel off the silver seal located over the area labeled "SCRATCH HERE."

Ensure the 6-digit code beneath the seal is clearly visible in your image.
